Modern Slavery Statement 2023

Introduction

Modern slavery can take various forms such as forced labour, involuntary work, human trafficking, exploitation or worst forms of child labour and is a criminal violation of fundamental human rights. The United Kingdom Modern Slavery Act 2015 is worldwide the first law that requires companies doing business in the United Kingdom to ensure that no form of modern slavery in their business or supply chains occurs.

Kelvion Holding GmbH and its affiliated group companies (hereinafter jointly referred to as “KELVION”) issued this statement in accordance with section 54 of the United Kingdom Modern Slavery Act 2015. This statement has been released and approved by KELVION’s Management Board for the financial year ended 31st December 2023.
